



Smith County Quilt Brochure – Northern Tour


These directions will take you from quilt to quilt. We have attempted to keep you on the major highways rather than the backroads as much as possible. The directions are broken down into separate sections picking up at the last quilt and carrying you to the next. The starting and ending point is the Smith County Chamber of Commerce office.




- 1 Depart Smith County Chamber of Commerce on Upper Ferry Rd (North-West) for 0.6 mi
- 2 At 203 Upper Ferry Rd. (**Quilt #1**), bear RIGHT (North) onto Old SR-25 [Main St N] for 0.2 mi
- 3 At 302 Main St. N (**Quilt #2**), turn RIGHT (East) onto 3rd Ave E, then immediately turn LEFT (North) onto Fittrell Alley for 0.1 mi
- 4 At 107 Third Ave. (**Quilt #3**), turn LEFT (West) onto Ward Ave E for 54 yds
- 5 At 330 Main St. N (**Quilt #4**), turn RIGHT (North) onto Old SR-25 [Main St N] for 109 yds.
- 6 Arrive 505 Main St. N (**Quilt #5**)




- 1 Depart 505 Main St. N (**Quilt #5**) on Old SR-25 [Main St N] (North) for 0.5 mi
Bear RIGHT (North) onto Main St N for 142 yds
Road name changes to SR-263 [Main St N] for 153 yds
- 2 At 1314 Main St. (**Quilt #6**), return East on SR-263 [Main St N] for 142 yds
Turn RIGHT (West) onto SR-25 for 0.2 mi
- 3 Arrive 33 Dixon Springs Hwy. (**Quilt #7**)



- 1 Depart 33 Dixon Springs Hwy. (**Quilt #7**) on SR-25 (West) for 8.3 mi
Turn RIGHT (North-East) onto Local road(s) for 131 yds
- 2 At 868 Dixon Springs Hwy. (**Quilt #8**), return South-West on Local road(s) for 131 yds
Turn RIGHT (North) onto SR-25 for 1.4 mi
Turn RIGHT (North) onto Local road(s) for 76 yds
- 3 Arrive 1004 Dixon Springs Hwy. (**Quilt #9**)



- 1 Depart 1004 Dixon Springs Hwy. (**Quilt #9**) on Local road(s) (South) for 76 yds
Turn LEFT (East) onto SR-25 for 6.5 mi
Turn LEFT (North-East) onto SR-80 for 0.3 mi
- 2 At Hwy 80, stay on SR-80 (North-East) for 5.5 mi
Turn LEFT to stay on SR-80 for 1.9 mi
Turn LEFT (West) onto Local road(s) for 43 yds
- 3 At 4 Shady Circle (**Quilt #10**), return East on Local road(s) for 43 yds
Turn RIGHT (South) onto SR-80 for 5.1 mi
Turn LEFT (East) onto SR-85 [Smith Branch Rd] for 1.8 mi
Turn LEFT (North) onto SR-85 for 1.4 mi
- 4 At 315 Defeated Creek Hwy. (**Quilt #11**), stay on SR-85 (East) for 3.2 mi
Turn LEFT (North) onto Local road(s) for 54 yds
- 5 At 21 Kempville Hwy. (**Quilt #12**), return South on Local road(s) for 54 yds
Turn LEFT (East) onto SR-85 for 1.6 mi
Turn RIGHT (South) onto Buffalo Rd for 1.2 mi
- 6 At 218 Buffalo Rd. (**Quilt #13**), stay on Buffalo Rd (South-West) for 0.5 mi
Turn RIGHT (West) onto Harris Hollow Rd for 0.5 mi
Turn LEFT (West) onto Local road(s) for 32 yds
- 7 Arrive 290 Harris Hollow (**Quilt #14**)



These directions take you from the last quilt in the Northern Tour back to the Chamber office. This route backtracks the way you just arrived. Feel free to consult a map or GPS for an alternate route to your destination.

- 1 Depart 290 Harris Hollow (**Quilt #14**) on Local road(s) (East) for 32 yds
 Turn **RIGHT** (South) onto Harris Hollow Rd for 0.5 mi
 Turn **LEFT** (North) onto Buffalo Rd for 1.7 mi
 Turn **LEFT** (West) onto SR-85 for 6.2 mi
 Bear **LEFT** (South) onto SR-263 for 4.3 mi
 Keep **STRAIGHT** onto SR-263 [Main St N] for 0.9 mi
 Road name changes to Main St N for 142 yds
 Bear **LEFT** (South) onto Old SR-25 [Main St N] for 0.7 mi
 Bear **LEFT** (South) onto Upper Ferry Rd for 0.6 mi
- 2 Arrive Smith County Chamber of Commerce
